Also, if needed, replace the outside door of the reading room so that it can be unlocked for outside entry. There is money remaining in the construction account that can be use for this purpose.

### New Business

**Closed Meeting Minutes:** Mark Oldenburg moved to leave these minutes closed for another year, seconded by Barb Sucich. Motion carried.

**Prevailing Wage:** Larry Stanford moved to accept the Prevailing Wage Ordinance 2023/24-002 as presented, seconded by Michael Merline. Roll Call Vote: Dave Drew, yes; Karen Breunig, yes; Michael Merline, yes; Mark Oldenburg, yes; Larry Stanford, yes; Barb Sucich, yes. Motion carried.

**Decennial Committee:** The Decennial Committee on Local Government Efficiency Act requires all Illinois local governments that impose a tax to convene a committee to study and report on local government efficiency. Under this law, impacted local governments must: 1. Form a committee to study local efficiencies and meet for the first time no later than June 10, 2023. 2. Have the committee meet at least three times. 3. Prepare a written report with recommendations (if any) on efficiencies and increased accountability. 4. File the report with county (or each county in which your government is located). The CBP Library District will hold its first meeting on April 11. Two local residents of the district will be asked to join the meeting along with the library district board trustees and library director.

<u>Adjournment</u> Mark Oldenburg moved to adjourn the meeting, seconded by Larry Stanford. Motion carried. Dave Drew adjourned the meeting at 8:28 p.m.
